ACTION TAKEN: Interview of **03 04**) on 12/17/12 at 1030 hours

On the above mentioned date and time this Detective and Det. Downs interviewed **04** at the Newtown Police Department.

At approximately 1030 hours on 12/17/12, **04** H **04** began her statement **04** completed her written statement at 1101 hours on 12/17/12. **04** swore to and signed her statement. (See attached written statement) The following information is taken verbatim from the signed and sworn statement of **04** :

"On 12/14/2012 I was going to Sandy Hook Elementary School to help make gingerbread houses in **04** class. I was due at the school at about 0945 in the morning. When I arrived at the school, I noticed five children running down the street near the stop sign before you pull into the school. I thought that the school was conducting a drill, it did not really register that something was wrong. I pulled up and parked my vehicle in the third row of parking spaces. At this point I think I heard banging metal sounds, and I thought it was construction noise coming from the building. As I approached the entrance to the school, I noticed a black Honda parked in front of the school with its passenger side door open, and it looked like there were two black blankets on the ground near the car.

As I walked toward the door I stepped on what I thought was rock salt on the sidewalk, then I saw the broken glass window next to the entrance doors. I saw a bullet hole in the glass, and then I realized there was a something bad going on and I needed to get away from the front of the school. As I was turning away from the school, I noticed another woman walking toward the school. At this time I heard sirens in the distance. We both heard what I now know was gunfire, and we ran to the right side of the dumpsters to hide. Police officers arrived and we identified ourselves to them. I called my husband on my cell phone to tell him what was going on. I called my husband at 9:42 am on my cell phone. One Newtown Police officer and one State Police Officer came over to protect us. I was behind the dumpster for about an hour because the last call made on my phone before I left from behind the dumpsters was made at 10:21 am. This is all I can remember right now." END OF STATEMENT.

In addition to the information contained in the statement, [REDACTED] 04 also provided the following information verbally:

[REDACTED] 04 stated that she arrived at the school early for her 0945 appointment. [REDACTED] 04 said she knows this because her call to her husband at 9:42AM was placed when she was behind the dumpsters after running from the front of the school. [REDACTED] 04 also added that the front door to the school was locked. [REDACTED] 04 said that the banging noises she initially heard stopped, and then started again. [REDACTED] 04 was not able to recall how many gunshots she heard.
