DATE AND TIME: On January 17, 2013 from 1210 hours to 1250 hours.

LOCATION: This interview was conducted in the roll call room at Troop A, 90 Lakeside Rd. Southbury, CT 06488

**ACTION TAKEN:**

On 01/16/13, I was assigned to contact and interview 04 regarding the shooting at Sandy Hook Elementary School. 04 was at the school during the shooting to assist 01 02 03 12 class in making gingerbread houses. At approximately 1555 hours, I left a voicemail message on his home phone. At approximately 1605 hours, 04 returned my call and agreed to come to Troop A on 01/17/13 to provide a written statement.

On 01/17/13 at approximately 1210 hours, [04] arrived at Troop A to provide his statement. The following is a summary of the statement provided by [04]

[04] stated that on 12/14/12, he came to Sandy Hook Elementary School to make gingerbread houses with [01 02 03 12]. He stated that he was supposed to be there by 0945 hours. He stated that he arrived early and was there at 0935 hours. He stated that he knows the time because he called "911" from his cell phone at 0936 hours. He stated that he parked his car and when he exited his car, he saw a group of children running in a straight line down the sidewalk in front of the school. He stated that he recognized one of the students as [01 02 03 12]. He stated that as he approached the front door, he heard a series of popping noises which he later discovered to be gunshots. He stated that he observed glass fragments on the ground and saw a hole in the glass adjacent to the front doors. He stated that is when he realized that the popping noise was someone shooting a gun inside the building. He stated that he called "911" to report the incident and it seemed like someone had already called in. He stated that he believes he ran to the left side of the building to get to [01 02 03 12] classroom. He stated that he tried some of the doors and looked into the windows to try to find [01 02 03 12] class. He stated that several police officers approached him and ordered him to the ground. He stated that he was handcuffed and led to the parking lot. He stated that Captain Rios asked another officer to unlock the handcuffs and then he waited in the parking lot for [01 02 03 12] class to come out of the school. He stated that once her class came out of the school, he joined the class and helped get them all to the firehouse (see attached statement).

CASE STATUS:

This case remains ACTIVE pending further investigation.
