ACTION TAKEN:

On 04/25/13, at approximately 1500 hours, Detective Downs and I met with **04, 03** [Redacted], with regards to the ongoing investigation. **04** was identified as the woman/parent who, on 12-14-12, took five of the 11 children, who escaped from the shooter in **01 02 03 12** [Redacted] at SHES, to the Newtown Police Department. 04 stated, in part, the following:

That on 12-14-12, she was on her way to SHES to participate in a gingerbread house building event 01 02 03 12, 04. 04 stated that she left her house at approximately 9:40 AM to be there for 9:45. 04 stated that when she got to the area of Cherry Street, which is before the hill that is prior to Mr. Rosen's house and her daycare woman's, 04 house, she looked ahead and saw a group of five children running in the road with a car moving slowly behind them. 04 verbally stated to us that she at first thought that there was a running group for children and then realized that could not be right. 04 stated that she recognized one of the children in the group to be 04, 01 02 03 12. 04 stated that she stopped her car in the middle of her lane and got out and told the children to stop. 04 stated that they were running really fast and when they stopped, they were crying and screaming and she heard one of the children say "a man with a gun trying to kill us." 04 stated that 01 02 03 12 recognized her and she 04 told 01 02 03 12 and the others to get in her car. 04 stated that she recognized the other children as 01 02 03 12. 04 stated that the children got into her car, but still seemed like they were trying to get away. 04 stated that she called the school because she still wasn't sure if what the children were saying was true and no one answered at the school. 04 stated that at that point, she knew that something was very wrong. 04 stated that she called the police department (Newtown) and told them what she found and the police told her to bring the children there. 04 stated that another parent, 04, was parked behind her on the road and she came into 04 car and sat with the children in the back seat to calm them down. 04 stated that they then decided to head to the police department and 04 followed in her car. 04 stated that there were other people there helping, but she does not remember who. 04 stated that she called her daycare woman, 04 and told her to call 01 02 03 12 mother and meet her at the police department. 04 stated that she proceeded to the police department without stopping and she could see the police (state) coming off the exits of I-84 to go to the school. While at the police department, 04 was brought with the children into a room and given a pad and paper to take down the children's names and contact information. 04 stated that when 04 01 02 03 12 mother, came into the police department, 04 left to 04, 01 02 03 12. 04 stated that when 01 02 03 12 grandparents came, she then 04, 01 02 03 12 left the children with 04. 04 stated to us verbally that she was not sure where the children were running to. She thought that maybe 01 02 03 12 was leading the group to 04 daycare person, 04 home, which was down the street, because 01 02 03 12 went there sometimes after school. 04 also verbally stated that the children only told her that there was a man in the school trying to kill them, that their teacher got shot, and that some of their classmates got shot. 04 stated that they kept saying that over and over and all at once, and never used specific names.

04 also verbally stated, when asked, that she did not see the other children, who at that time should have been in Mr. Rosen's driveway.
04 also stated that she is not sure if she would have noticed them as she was focused on getting to the police department.

See attached written statement prepared and notarized by this Detective, witnessed by Detective Downs, and sworn to and signed by **04**

Detective Downs and I measured, with his department assigned vehicle's odometer, the distance from the intersection of Riverside Drive and Cherry Street to Dickinson Drive, and the distance is approximately a 1/4 mile. We estimated that the children ran approximately a 1/2 mile from the entrance of the school.

CASE STATUS: This case will remain active pending further investigation.
