

See attached written statement prepared and notarized by this Detective, witnessed by Detective Downs, and sworn to and signed by

Detective Downs and I measured, with his department assigned vehicle's odometer, the distance from the intersection of Riverside Drive and Cherry Street to Dickinson Drive, and the distance is approximately a 1/4 mile. We estimated that the children ran approximately a 1/2 mile from the entrance of the school.
