On 06/05/13, I was assigned to review a supplemental report for TFC Faughnan's initial response to Sandy Hook Elementary School and 36 Yogananda St. in Newtown, CT. The report details his response from Ridgefield to Sandy Hook Elementary School, his actions at the school as well as his response to the Lanza residence on Yogananda St. and his actions at the residence. **ACTION TAKEN:** On 12/14/2012 at approximately 0949 hours, I was assisting Tfc. Derderian #708 with an explosive class at Boehringer Ingelheim Pharmaceutical at 900 Ridgebury Rd, Ridgefield, Ct. While at this location I was notified by CSP HQ Ever-Bridge that there was an active shooting at the Sandy Hook Elementary School in Newton. I informed Tfc. Derderian of the situation and left the facility in my assigned cruiser, silver 2007 Ford Explorer with my lights and siren activated and responded to Sandy Hook School via I-84 E/B.

As I approached the school at approximately 1009 hrs, I observed numerous civilians in the parking lot. I pulled in behind Tpr. Poach and Sgt. Bartalotta and began putting on my assigned tactical gear, [REDACTED] 13, 14 [REDACTED]. I informed Tpr. Poach that we'd meet inside. Once I had my gear on I headed to [REDACTED] 13, 14 [REDACTED] of the school, where I observed numerous children running from the school screaming and crying.

As I ran along [REDACTED] 13, 14 [REDACTED], I observed a side door that had a window pane broken out, but the door was closed. I made entry into the school at [REDACTED] 13, 14 [REDACTED] entrance and observed Sgt. Tom Bennett standing post at classroom doorway.


Once in the school I turned right and traversed down [REDACTED] 13, 14 [REDACTED] hallway, back to the [REDACTED] 13, 14 [REDACTED] classrooms. As I approached the [REDACTED] 13, 14 [REDACTED] I observed a SNTF Trooper standing post at the entrance to a classroom. I then observed a 30 round magazine on the floor with several rounds expended from the magazine. I then turned left and traversed [REDACTED] 13, 14 [REDACTED] hallway.

I passed by the classroom at the [REDACTED] 13, 14 [REDACTED] corner where the SNTF Trooper was posted, I observed Lt. Hofbauer at the next classroom doorway, made entry, observed numerous deceased bodies, turned and exited the classroom moving towards the next classroom. I approached the next classroom, observed a deceased male lying on the floor at the classroom entrance. I entered the classroom, observed numerous deceased bodies, turned and exited the classroom moving towards the next classroom. As I approached the next classroom, I observed two deceased females laying in

the hallway. I then entered the next classroom, cleared it visually, observing no children and exited the room. I then approached the front lobby where I observed Lt. Mike Perry.


I spoke with Lt. Perry and informed him that I wanted Officers at every classroom or at the hallways until we had enough officers to cover the classrooms. I further informed him that I and Tpr. Poach were going to clear classrooms visually and physically. I gathered approximately ten officers from numerous towns and divided them into two groups of five with Tpr. Poach leading a group and I the other. While we were stacking in the hallway, someone heard noises in the first classroom, across from the main office.

Tpr. Poach and I entered the classroom and I approached a closed door in the corner which was block with bookshelf. As Tpr. Poach posted on the door, I moved the bookshelf and ordered the individual(s) out of the closet and identifying myself as a State Trooper. After several verbal attempts, I attempted to open the door and observed the door handle was locked. I asked tall police officer from an unknown town for his badge so that it could be slide under the door, so that the individual(s) would know we were the police. I received a master key, I was kneeling, Tpr. Poach was posted over me and the unknown officer was against the wall. I unlocked the door handle, as I attempted to push the door open it was forced close, the unknown officer held the door open once I was able to push it open. When the door opened I observed numerous children in a small bathroom with blonde female teacher holding the children back. The teacher began to yell at me "You're not the police, I don't believe you", she repeated this several times and which time Tpr. Poach grabbed a couple of children and the others followed. As the children exited the bathroom they were passed off to the officers and escorted out of the classroom. I stayed kneeling and the teacher stayed motionless against the bathroom wall, continuously repeating "You're not the police, I don't believe you". Once the last child exited the bathroom I reached in and grabbed the teacher, later identified as Kaitlin Roig and she became hysterical and I physically escorted Roig from the school exiting through a classroom door at the **13, 14** corner.

Once Roig was in the care of a female Trooper I reentered the school and was informed by Lt. Perry that there might be other teachers in lock down in the library area. With Tpr. Poach and several officers from unknown towns we entered the library and directed to another door within the library. As Tpr. Poach and I entered the storage area I made announcements "State Police", observed another door and heard a female voice. I stated that we were the police and

the woman asked "How do I know you're the police?" I told her I would slide a patch under the door, and asked an unknown police officer for his uniformed patch, but several police radios went off and the woman stated that she believed me. She then stated that the door was blocked, I unlocked the door, forced the door open and observed the teacher, later identified as 04 [REDACTED] and nineteen other students in the closet. Again we escorted all the teachers and students out of the school through the 13, 14 classroom door.

I then went to the front lobby to gather more officers for a complete search of the school. While at the front entrance I observed several Ct State Police Tactical Team members arriving in the parking lot. I waited until the team was assembled in the school, I took my place as "key master" as I still had the master key. As the team cleared the rooms I opened any unlocked doors. We cleared the school and assembled again outside and I was informed that we were going to the suspect's residence.

Once the suspect's residence I was informed that I would 13, 14 [REDACTED] look for other suspects, victims or booby traps. The West Tactical team breached several points of entry at the residence and then 13, 14 [REDACTED] I entered the residence and searched the first floor with negative results for booby traps, suspects or victims.


13, 14 [REDACTED] and as I searched the rooms, I located a deceased female in a bed and a rifle on the floor. I entered the suspect's room and noticed that the windows were covered in some type of plastic and it was very dark in there. I did not locate any other victims, suspects or booby traps. Once the residence was cleared enough 13, 14 [REDACTED] the East Tactical team made entry and cleared the residence.

Once the team exited the residence, Tfc. Derderian and myself then entered the residence in our EOD capacity to clear the suspect's room and den/computer room to do a physical search of the draws and closet for possible IED or booby trap materials. We located none in the bedroom. In the den/computer room I located numerous shotgun shells emptied of their smokeless powder, but no components or powders for an IED. While we were searching the residence a UPS delivery truck arrived and we were informed that there was a delivery for the suspect's residence on the truck. I

entered the UPS truck and observed two boxes from a known store. I opened the boxes to ensure that there were no IEDs or other criminal material inside of them. The boxes contained personal products for the residence.

We then left the residence and were requested back at the school for debriefing. We assisted the CI Unit setting up their stations and then left the school at approximately 1830 hrs.

At approximately 2200 hrs, I received a phone call from Tfc. Derderian that the FBI was requesting a bomb tech to assist with the seizure of fireworks at the suspect's father's residence (100 Bartina Ln, Stamford). I arrived and observed a small quantity of illegal fireworks, the FBI evidence team photographed the items and a member of the CSP CI Unit sieved the fireworks. While there the FBI investigators asked me to do a walk thru of the residence for items that might be related the suspect's primary residence. I did not locate anything related the suspect's residence at this location.
