INTERVIEW REPORT

Date and Time of Investigation:

Friday, December 14th, 2012 at approximately 0930 hours.

Summary of Incident:

On the above mentioned date and time members of the Western District Major Crime Squad responded to the scene of an active shooter within the Sandy Hook Elementary School located at 12 Dickerson Drive Newtown, CT.

As a standard procedural function in this type of investigation several witnesses were interviewed throughout the investigation.

Action Taken:

On Saturday, December 15th, 2012 between 1343 and 1433 hours I, Det. Roy # 518, interviewed Kenneth Lerman. Mr. Lerman was a First Responder with the Newtown Ambulance Corps that transported two patients to Danbury Hospital shortly after the shooting. Mr. Lerman provided the attached written statement. In summary the statement reads as follows:

I making this statement in regards to my participation in an ambulance call that occurred 12/14/12 at approximately 9:30 a.m. I have volunteered for the Newtown Volunteer Ambulance Corps for the past 15 years approximately. I was at home reading my e-mail when I heard an ambulance dispatch calling for two ambulances to stage at a church in Sandy Hook. I responded to the garage in my personal vehicle. While in route to the garage I heard another EMT sign on responding to the garage. I rolled Ambulance A-3 and waited outside the bay for the other responder. Seconds later Laurie Veillette got out of her car and entered the ambulance. While in route to the church we were redirected to stage at the Sandy Hook Fire House. While staged we spiked a bag. A short time later a State Police car came up Dickerson Drive at a high rate of speed and stopped in front of the ambulance. In the front passenger seat was a female with a bandage covering her right calf and a bandage on her hand. The fingers of both hands were blood stained. She was initially placed on a cot and put into the ambulance. While treating her, a second patient was brought into the ambulance. The second patient, a male child, had injuries [REDACTED] 03, 12 [REDACTED] The first patient was transported to the front seat and the second was placed on the cot. The paramedic, Dan, had told me to start the drive to Danbury Hospital. While in route the hospital was notified the number and condition of the patients. Care was turned over to Danbury Hospital Emergency Staff with a brief report so we could return to service. END OF STATEMENT.
