AE911Truth had an exceptional 2014 Early in the year, we completed an historic 17-city tour of Canada From Victoria, in the province of British Columbia, to St Johns in Newfoundland, we reached hundreds of audience members at in-person presentations as well as millions more via radio interviews This tour helped encourage 50 concerned Canadians to seriously consider running for parliament In May, we challenged the official account of 9/11 by passing out, to thousands of tourists, an alternative brochure at the Grand Opening of the 9/11 National Museum When CNN dended our effort to educate museum-goers, millions of the TV networks viewers learned about AE911Truth In June, we attended the AIA National Convention in Chicago, where a dozen local activists working at our expo booth helped us garner 120 new architect and engineer signatories to our petition We also educated thousands of convention attendees about the destruction of the three WTC skyscrapers Our outreach to the American Institute of Architects paid off when we were invited to two conference calls with national AIA executives to discuss the possibility of sharing the WTC evidence with the organizations membership base In August, through the diligent work of one of our most dedicated AE911Truth activists, Richard Gage was able to reach 3 million television viewers in a 45-minute interview on C-SPANs popular Washington Journal program Also in August, we managed the marketing and distribution of David Hoopers new film, The Anatomy of a Great Deception, which went on to become a huge success, especially among new-to-9/11 Truth viewers Indeed, it has since surpassed Experts Speak Out to become our most popular DVD to date During the thirteenth anniversary of 9/11 in New York City, we mobilized the 9/11 Truth Movement to financially support the posting of a massive 90-foot-wide video billboard in Times Square showing the destruction of WTC 7 It wrapped around a highly visible corner of the square one block north of the New York Times Building and across from the Port Authority Bus Terminal, allowing for the destruction of WTC 7 to be seen by millions of onlookers throughout the month of September The same week, AE911Truth hosted, in front of a sold-out theater audience, a major 9/11 Truth Symposium, which featured half-a-dozen noteworthy speakers, including family members and survivors AE911Truth rounded out the week by holding a major press conference at Ground Zero
